- LYONS: I know. I know. But the thing is, is that she got hurt. You know what I'm saying. And you were there in the apartment with her, and, you know, when the law came by today to call.. to call on you and check on her and everything, and you hadn't let them in.

Okay, I., I'm going to tell you now, from sitting here, in the pass few minutes, even though you've been to the pen. I'm not about to buy for a minute, that you're a hardened person or that you are a cold blooded killer. And I don't think you should be viewed that way. I. J., there's... you're just not a... but the key to not being viewed that way, and to be viewed by other people as somebody that made a mistake, or have something got out of control or something happened, is to.. is to put some reason, honest reasoning behind that. Okay. Because in the long run, what people are going to ask, is for an explanation. And if it turned out, that weighs heavily on what happens. That's how.. people perceive... you've been.. have you been to trial before on any of your...
